RENTAL CONDITIONS

THIS SIGNED AGREEMENT IS IN EFFECT EACH TIME A CART IS RENTED BY THE LESSEE

1. Lessee/Operator must be at least 18 years of age. Should lessee allow children under the age or an unlicensed driver operate the golf cart, the terms of this agreement shall have been breached and lessee would be subject to forfeiture of his/her deposit.
2. Operator must have a valid driver's license. A copy is required.
3. Lessee is prohibited from leasing vehicle to other parties.
4. No more than 2 people to ride in a two passenger cart, 4 persons in a four passenger cart and 6 persons in a six passenger cart.
5. Lessee is totally responsible and liable for the cart and the actions of its driver and occupants.
6. Lessee must return cart during office hours or deposit is forfeited.
7. Lessee is totally responsible for any and all property damage caused by cart leased in his/her name.
8. Rentals rates are charged by the day. If the cart is returned after the rented terms, the next day will be charged accordingly.
9. Lessee is responsible for and will reimburse leaser on demand for all loss or damage to cart tires, accessories and/or equipment.
10. Leaser shall not be liable for loss or damage to cart or any property left, stored, or transported by lessee or any other person in or upon vehicle either before or after the return thereof to leaser whether or not said loss or damaged was caused or related to the negligence of lessee, or it's agent or employees. Lessee hereby assumes all risk of such loss or damages and waives all claims against leaser and will indemnify leaser for all claims based upon or arising out of such loss or damages.
11. Lessee agrees to hold lesser harmless and to indemnify leaser against any loss arising out of the leased vehicle or anyone who operates said vehicle with lessee's permission. Lessee agrees to reimburse leaser for any loss sustained as a result of any claim made against them, including reasonable attorney's fees.
13. A \$300.00 damage deposit is required.
14. Lessee has read and understands the above Rules and Conditions.
